





# Watching stormy seas from the shore



## Watching stormy seas from the shore

- Get a weather report (*potential legislative reform etc*)
- Scan the sea for rip tides (contingent liabilities, underpayments)
- Fathom your resources (measure and assess reserves)
- Install a speedometer (*dashboard reporting*, *lead indicators etc*)
- Dry dock your boat (*program reviews*, *exist misaligned businesses etc*)
- Get the right crew (*skill and experience of directors and senior managers*)
- Develop your sailing plan (*update strategic and workforce planning etc*)
- Undertake voyage planning (*organic, accretive, merge, JV etc*)

# **Steering the ship in rough seas**



## **Steering the ship in rough seas**

- Wish you went ship shopping earlier? (*large vs nimble models*)
- Sail upwind or downwind? (grow or shrink?)
- Bring in more navigators (*advisors, mentors etc*)
- Adhere to navigation and sailing rules (director duties/insolvency)
- Avoid windward side / Sail to the leeward side of islands (strengths)
- Sailing in a fleet? (is group think appropriate for the times?)

# Time to start bailing the water



## Time to start bailing the water

*'Foundering' - a seafaring term for when a ship is so filled with water that she cannot veer nor steer.* 

- Engage a maritime pilot (*liquidator/administrator*)
- Deploy the lifeboats (*strategies for orderly wind down*)
- Call in the rescue helicopter (*who is going to come?*)
- Walk the plank (*recrimination distraction*)
- Dealing with people leaving the 'sinking ship' early (best staff may leave)


# **3. Practical Steps to manage risk**



### **Practical steps**

- We are all in the same boat (lots of sector and other supports)
- Get your ship in order (*due diligence activities etc*)
- Plan your journey before you sail (*importance of strategic planning*)
- Determine who the captain is (*Chair/CEO are governing/operating*)
- Get everyone to row in unison (*organisational cohesion*)
- Keep a sailors diary (good minutes to justify business judgement)
